Finance Committee Meeting Minutes – June 18, 2025

Present: Zale Palmer, Clif Warren, Colleen Culwell and Donna Griffin.

Clif called the meeting to order at 10:02 a.m.

Clif moved to approve the minutes of the May 14, 2025, Finance Committee meeting. Zale seconded the motion. Passed, all in favor.

The committee reviewed the May 2025 financial statements. Clif and Zale noted high Administration expenses due to Accounting costs. Colleen explained that this expense included the wrap up bill for the Audit. Preventative maintenance increased in May. Mountain bus Preventative Maintenance was more than \$10,000. SPOT received \$6,000.00 for the first advertisement. Area Agency on Aging has an advertisement on the rear panel of bus 125 for 6 months. Clif moved to accept the April 2025 financial statements. Zale seconded and it passed, all in favor.

The committee considered interest rates at area banks. Upon research we found others that offer up to 1% more than our current bank. The committee agreed to present the information to the SPOT Board when the maturity date for the current CD draws near.

The Committee discussed and considered the 2025-2026 budget information. Donna stated that our insurance (ICRMP) rate may increase by \$3,700. Finance committee members offered feedback on the presentation slides for the June 2025 Sandpoint City Council meeting.

Clif made a motion to adjourn the meeting. At 11:07 a.m. Zale seconded, and it passed, all in favor.
