Finance Committee Meeting Minutes – July 16, 2025

Present: Zale Palmer, Clif Warren, Colleen Culwell and Donna Griffin.

Zale called the meeting to order at 10:02 a.m.

Clif moved to approve the minutes of the June 18, 2025, Finance Committee meeting. Colleen seconded the motion. It passed, all in favor.

The committee reviewed the June 2025 financial statements. Zale noted high preventative maintenance costs for the mountain buses. Colleen mentioned that we received one more bill for the 2024 Audit from Alpine Summit. Zale and Clif asked about the eBay bill - which was for a wheelchair lift part for a bus. Clif asked about the DoubleMap line item. We no longer use DoubleMap. SPOT continues working with PASSIO and vice versa to overcome the system glitches. Donna continues to work with PASSIO and SHI on the annual service billing. The billing still shows the annual service starting in November 2024 through October 2025. But they installed the equipment in mid-February 2025 and the service barely worked until April 2025. Colleen said that the State reimbursements fell behind and they missed the January CARES payment. It should arrive soon. Clif moved to accept the June 2025 financial statements. Zale seconded and it passed, all in favor.

The committee considered the SPOT Bus 2024 Audit information prepared by Alpine Summit CPAs. In summary, the Independent Auditors' Report contained no discrepancies.

The Committee discussed and considered the current 2025-2026 budget information including projected revenues. The Finance Committee will host a special meeting on August 5, 2025, at 9:00 a.m. to work on a proposed 2025-2026 budget for SPOT Board consideration at their August 21, 2025, meeting. By then we should have a clearer picture of SPOT local match revenue.

Zale made a motion to adjourn the meeting at 10:45 a.m. Clif seconded, and it passed, all in favor.
